## NCMA-SD's Mark Cook Selected for the NCMA Leadership Development Program!

The NCMA San Diego Chapter is proud to announce that Mark Cook is one of 32 candidates selected from a pool of 82 highly qualified applicants to participate in the **NCMA LEADERSHIP DEVELOPMENT PROGRAM**.

NCMA has designed a program to help develop the next generation of contract management leaders through an intensive year-long educational experience. This Leadership Development Program was kicked-off in Cincinnati June 22 at the annual NCMA Leadership Development Conference.

Mark is the Program and Financial Control/Analyst for KES, Inc and is responsible for the budgeting, pricing, and invoicing of all KES contracts. For the past two years, Mark has been an active participant on the NCMA-SD Chapter Board. During the 2005-06 program year Mark was our Membership Director and also helped filled the Treasurer position. For the 2006-07 program year, Mark is our Treasurer.

### ***The Program***

The contract management workforce is facing one of its greatest challenges ever—the workforce is aging and retiring at a pace faster than the next generation is replacing them. This has created a gap across the entire profession; there are simply not enough high-quality contract management professionals to meet today's needs—and the outlook for the future remains challenging. The NCMA Leadership Development Program is designed to quickly close the gap in leadership progression by accelerating the preparation of a select group of contract management professionals.

The ideal participants are in the early stages of their careers, not yet having achieved the management level. They have an undergraduate degree, some experience in the contract management field, and may have already completed an MBA program. Their employers consider them amongst the top performers in their workplace and they have a high degree of potential for advancement. This program is for “the best of the best.”

In addition to the extensive classroom and Web-based coursework, the program includes a series of assignments designed to round out the participants' development. These include serving as a volunteer NCMA leader at a local chapter as well as for the national organization. The participants are also matched up with two or more mentors, who will coach them through the entire program. These mentors come from most experienced and accomplished people within our profession—our NCMA Fellows.

## NCMA Certification Study Group Is Under Way

A couple of years ago, NCMA National revamped its certification program. Now, NCMA members with specified experience and education may test to be certified as Certified Federal Contract Managers and as Certified Commercial Contract Managers. Members who achieve both certifications automatically become Certified Professional Contract Managers.

There are three separate exams for the CPCM certification. A general business exam is required for both CFCM and CCCM. Then, applicants take a federal contract knowledge exam for the CFCM and a commercial contract knowledge exam for the CCCM. Seven eager members of the NCMA San Diego chapter have formed a study group to prepare for the NCMA certification exams. The study group meets each week for two hours. In preparation for the weekly meeting, designated members prepare a written synopsis of that week's chapter from the NCMA study guide, and also prepare mock exam questions. The members then brief their outlines to the entire study group, and the group answers the mock exam questions.

The study group is now preparing for the general business knowledge exam. The team advises that it is willing to admit new members to the study group when they begin their preparation for the federal and commercial exams. ## NCMA Leadership Conference, June 23-24

NCMA National held its 5<sup>th</sup> Annual Leadership Summit in Cincinnati, OH on June 23 and 24. Conference attendees included NCMA chapter officers from all over the country. Several San Diego chapter members attended.

The conference featured over 20 plenary sessions and workshops. Incoming NCMA President Len Vincent spoke on the topic of "The State of Contract Management: What's Happening in our Profession." There was a fascinating talk by an NCMA Fellow who had recently returned from Iraq about the challenges of contracting in a war zone. And the NCMA directors and officers conducted "town hall" sessions to answer questions about the association. There were also workshops on a number of topics relevant to NCMA chapter leaders. The workshops focused on chapter finances, education programs, the NCMA fellow application process, attracting volunteers, and many other significant issues.

The conference also introduced the charter members of NCMA's new Leadership Development Program. Recognizing that the NCMA membership is aging and that there needs to be a structured process to bring in new members, NCMA started the program this year. Applicants were selected based on education and recognized high potential, and work in both government and industry. The approximately 40 new program members, who were selected from a large applicant base, will engage in a one-year program of education, training, mentoring, and experience. Our own chapter's Mark Cook was a selectee.

The program will seek and select members for next year's program in the first quarter of the year. ## NCMA Audio Seminar Debriefs

### April 2006 Seminar

The Organizational Conflicts of Interest (OCI) audio seminar held on April 18 was very well attended and provided insights into the pitfalls often encountered by firms doing business with the Government. Examples were given as to how the FAR and GAO defines OCI, how to avoid unfair competitive advantages in solicitations and contract awards and how to structure contracts to avoid OCI violations. The presenter was William Weisberg, partner and chair of the Government Contracts Practice of Sullivan & Worcester based in Washington DC.

### June 2006 Seminar

On June 20, NCMA San Diego Chapter hosted a “Contractor Team Arrangements and Alliances” audio seminar moderated by Michael Mutek, Vice President and General Counsel of Raytheon Intelligence and Information Systems. He thoroughly addressed the teaming arrangement concept – the reasons that companies form teams as well as the obligations, responsibilities, benefits, risks, alternatives and other factors associated with teaming. Mr. Mutek emphasized the importance of drafting an agreement that addresses both the issues posed by the opportunity as well as the business goals and needs of the individual parties. He introduced two panelists, Richard L. Farr, Senior Counsel of Harris Corporation and Pat Meagher, founding partner in the San Francisco law firm of Rossi & Meagher, both of whom have extensive backgrounds in public and government contract law. A model teaming agreement was provided and the panelists used it as a vehicle to highlight and discuss the many issues addressed in teaming agreements. One panelist represented the Prime contractor of the teaming agreement and the other panelist was an attorney representing their client as the subcontractor in the teaming agreement. The discussion was very well conducted and offered the listeners the opportunity to ask and have their questions answered.
